GENERAL CONDITIONS

1. Application received after the closing date for whatever reason is liable to be rejected.
2. If the fact that false information has been furnished or that there has been suppression of any material information in the application form comes to notice at any time during the service of a person, his service would be liable to be terminated.
3. Application not signed by the candidate is liable to be, rejected
4. The candidates who are employed should submit a 'No Objection' certificate from their employer at the time of written test. In case they do not furnish the same for some reasons or other, their candidature will straight away be rejected and they will not be entitled to any claim including T.A. from the Council.
5. The candidates must attach all the relevant documents
6. ST and non-creamy layer OBC candidates recognized by Central Government are directed to submit the caste certificate in prescribed format issued as per Government of India instruction by the competent Authority for appointment to posts under Government of India, failing which they will not be entitled to the concession admissible to them if any and application will be rejected.
7. The number of vacancies to be filled may vary at the time of actual selection. In the event of non-availability of suitable candidates for the advertised posts, the positions can be filled up at lower level. Allowances as per Central Government rules are admissible on the prescribed pay scales. Benefits of new restructured defined contributory Pension system are admissible as per the provision contain need in the Ministry of Finance, Department of Economic Affairs (ECD & PR Division), Notification No.5/7/2003-ECD & PR dated 22.12.2003 effective from 1.1.2004.
8. Candidates called for interview for the post of **Scientist-B and Scientist-C** will be paid 2nd class rail fare by shortest route on production of documents. No TA/DA is admissible for joining the post or on termination of appointment.

Demand Draft of Rs.500/- (Rupees five Hundred only) payable in favour of "The Director, Desert Medicine Research Centre, payable at Jodhpur should be enclosed along with application and should reach to this office on or before closing date. The SC/ST/Women/physically handicapped candidates (PH) and Ex-Serviceman are exempted from the application fee. All other / ICMR employees are not exempted from the payment of application fee. On the over leaf of demand Draft, the candidate must mention his/her name and post applied for. Fee once paid will not be refunded under any circumstances. Any other mode of payment viz. cash, money order and cheque will not be accepted.

Application from employees working in Centre/State Government Department/Public Sector Undertakings & Government funded research agencies must be forwarded through proper channel along with the certificate of the employer that the applicant will be relieved within three months of his/her receipt of appointment orders. Advance copies of application will be considered subject to the conditions that a '**No Objection Certificate**' from the employer is produced at the time of personal discussion. Application received after the closing date will not be considered. Candidates called for personal discussion/interview have the option to answer in Hindi.
11. Since it is not possible to call all the eligible candidates for the Interview, the applicants will be short-listed based on written test performance. The decision of the Director General, ICMR/Director DMRC will be final in this regard. Any canvassing by or on behalf of the candidates or to bring political or outside influence with regard to selection/recruitment shall be treated as disqualification.
