1. Age relaxation.

i. 5 years of age relaxation will be given for ST candidates against the reserve post for ST and 3 years age relaxation will be given for OBC candidates against the post reserved post OBC candidates. Five years relaxation will be given Government servants and 10 years for Physically Handicapped (PH) candidates.

2. Other Service Conditions:

i. Allowances as per Central Government Rules are admissible on the above mentioned pay scale

ii. Benefits of new restructured defined contributory Pension system are admissible as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division), Notification No.5/7/2003-ECB & PR dated 22.12.2003 effective from 1.1.2004.

iii. Applications from employees working in Central/State Govt. Departments/Public Sector Undertakings and Govt. Funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that a 'No Objection Certificate' from the employer is produced at the time of written test.

IV. Private practice is not allowed, however, non-practicing allowance is admissible to medical graduates only as per rule.

3. Application fee:

IPO/Demand Draft of Rs.500/- (Rupees five Hundred only) payable in favour of "The Director, Desert Medicine Research Centre, payable at Jodhpur should be enclosed along with application and should reach to this office on or before closing date. The SC/ST/Women/physically handicapped candidates (PH)/Ex-Servicemen are exempted from the application fee. All other / ICMR employees are not exempted from the payment of application fee. On the over leaf of demand Draft, the candidate must mention his/her name and post applied for. Fee once paid will not be refunded under any circumstances. Any other mode of payment viz. cash, money order and cheque will not be accepted.

(e) List of Publications mentioning clearly the 'Name of the Journal' and 'Impact Factor'

(f) One-self attested recent passport size photograph

- (g) ID Proof (Ex. PAN/Voter ID/Driving License etc.)
- (h) One set of self-attested photocopies of all documents
- (i) Application fee in the form of Demand Draft/IPO

II. Last Date for submitting completed applications **Only in Hardcopy: 13th August 2018 up to 5:30 pm**

5. Selection Procedure:

Written examination of the eligible candidates will be taken; candidates will be called for personal discussion/ interview on the basis of marks obtained in the written examination and marks for publication, experience, awards etc. The final selection will be as per criteria adopted by ICMR and decision of the Director General, ICMR will be final in this regards

Written Test: The written test would be of 100 marks consisting of 100 objective/ MCQ type questions of one mark each for the correct answer. The final score will be computed for a maximum of 40 marks based on the marks obtained in the written test of 100 marks. For each wrong answer 0.25 marks will be deducted. Out of 100 questions, 90 questions will be objective/ MCQ type and 10 objective/ MCQ for analytical skills.

- a. Level of questions will be M. Sc level.
- b. Questions will cover all the areas mentioned below:-

1. Bio statistics
2. Computing skills
3. General Scientific knowledge
4. Current Affairs including developments in Biomedical Sciences
5. Common sense
6. Institute specific areas
7. Post specific areas
8. Fundamental knowledge
9. Subject specific knowledge

6. General Instructions:

- i. Ph. D./M.D. degree in shall be treated equivalent to three years' experience. Candidates with Ph.D./M.D. degree will be preferred for direct recruitment.
- ii. Candidates called for personal discussion will be paid a 2nd Class rail fare by the shortest route, subject to production of documents along with proof of travel. Local transportation charges shall however be borne by the candidates themselves.
- iii. The post is with all India transfer liability under the Council.

- iv. The envelope containing applications should be super scribed – Application for the post of ‘Scientist B or C’.
- v. ST and non-creamy layer OBC candidates recognized by Central Government are directed to submit the caste certificate in prescribed format issued as per Government of India instruction by the competent Authority for appointment to posts under Government of India.
- vi. Unsigned/incomplete applications or applications without supportive evidence, without application fee (in the form of Demand Draft/IPO), applications received late, shall be summarily rejected.
- Vii DMRC Jodhpur will not be responsible for any postal delay/wrong delivery.
- ix. Date of written test / personal discussion will be communicated to the eligible candidates through call letters only and no enquiry in this regard will be entertained and all updates will be up-loaded in the website.
- x. No TA/DA will be admissible to attend the written test.
- xi. Canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection / recruitment shall be treated as disqualification
- xii. Any Addendum/Corrigendum in respect of above vacancy notice shall be issued on our websites www.dmrcjodhpur.nic.in . Applicants are requested to regularly visit our website to keep themselves updated.
